Re: MDR Request – FISA Warrants

To Whom It May Concern:

This is a request on behalf of the James Madison Project (“JMP”) pursuant to the provisions of Executive Orders 12958 and 13292 for Mandatory Declassification Review of:

- a) **Any and all requests for Foreign Intelligence Surveillance Act (“FISA”) warrants submitted by the National Security Agency (“NSA”) to the Office of the Secretary of Defense (“OSD”) or the Attorney General (“AG”) or the National Security Division (“NSD”) of the Department of Justice (“DOJ”), including all documents and affidavits included as exhibits in such warrant requests and all transcripts of testimony provided by federal agents in furtherance of such warrant requests;**
- b) **Any and all correspondence and emails between the NSA, the OSD, the AG’s office, the NSD, the Federal Bureau of Investigation (“FBI”), the Central Intelligence Agency (“CIA”), or the Foreign Intelligence Surveillance Court (“FISC”) regarding such warrant requests;**
- c) **Any and all transcripts of FISC hearings on such warrant requests that are**

**in the NSA's possession; and**

- d) Any and all copies of FISC rulings, decisions, briefs, or orders regarding such warrant requests that are in the NSA's possession.**

Even discounting the NSA's controversial Terrorist Surveillance Program, recent years have seen considerable public debate over the FISA and the role of the FISC. Through the end of 2004, the FISC approved 18,761 warrants, and rejected only five. It approved 2,072, in 2005, and 2,181 in 2006, rejecting none. In 2002, the FISC accused the FBI and DOJ of supplying "erroneous information" in more than 75 affidavits. Disclosure of responsive records pertaining to requests submitted to the OSD and/or DOJ for FISA warrants along with records regarding the ultimate fate of those requests would illuminate the standards by which these requests are evaluated at every level of review.

We do not authorize the NSA to assess any charges to us for the processing of this request without seeking our prior explicit authorization.

We request that any documents or records produced in response to this request be provided in electronic (soft-copy) form wherever possible. Acceptable formats are .pdf, .jpg, .gif, .tif. Please provide soft-copy records by email or on a CD if email is not feasible.
